SECTION 4. First aid measures

4.1. Description of first aid measures

SKIN: Upon contact with the product, the skin will stick to itself and to everything else immediately. Do not attempt to remove either contaminated clothing or the product from the skin, as adherent skin can easily tear. Wash the skin thoroughly with soap and water. Consult a doctor immediately. **EYES:** Rinse immediately with plenty of water. Continue rinsing for at least 10 minutes. In the event of sticking with adhesive, do not force the eyelids apart. Apply a swab soaked in warm water and allow the eyelids to separate. Consult a doctor. The solidified adhesive does not stick to the surfaces of the eyes but being abrasive can cause damage. 8.2. Exposure controls
